If the total rental time for the year is 3 months or less, you must file on a seasonal basis, which is a once-a-year filing. If the rental is during the winter months, a return will be due by April 20th, covering rentals through March. If the rental is during the summer months, a return is due by October 20th, covering rentals through September.

_____ SEMI-ANNUAL

Rentals in which **\$500.00** or less in tax is collected for a 6 month reporting period (October-March) taxes are due by April 20th. Reporting period (April-September) taxes are due by October 20th. Must file (2) returns annually.

_____ QUARTERLY

Rentals in which **\$1,000.00** or less in tax is collected for the quarter. A return is due by the 20th of the month following the quarter to be reported. Due dates for this filing are January 20, April 20, July 20, and October 20.

_____ MONTHLY

Rentals which do not qualify for seasonal, semi-annual, or quarterly will be due monthly by the 20th of each month following collection and will be delinquent on the 21st.

_____ LONG TERM
